**MS ACTE** is the professional association for individuals in career, vocational, technical, adult, and related areas of education. Academic educators involved in providing general education are also invited to membership, as well as anyone interested in the field of workforce training and development.

**MS ACTE** members are offered a wide range of opportunities to learn and share in leadership for vocational, technical, and adult education. A Board of Directors is in charge of the operation of the Association. This board is comprised of individuals from all areas of the profession as well as districts of the State.

**MS ACTE** organizes the State to form five districts. These MS ACTE districts are formed by clustering community/junior college districts as shown below.

**MS ACTE** is affiliated with the Association for Career and Technical Education (ACTE), with headquarters in Alexandria, Virginia. All memberships in MS ACTE include membership in ACTE. The ACTE is the national organization designed to serve the professional needs of vocational, technical, adult, and other educators with common interests. Membership in ACTE has automatic accidental death and dismemberment insurance on a public carrier. The coverage is \$25,000 the first year of membership and increases \$5,000 a year up to \$50,000 if no lapse occurs in the membership. If membership lapses, the coverage starts over at \$25,000 when you rejoin the association. Submit renewal application forms before the fifteenth of the month of membership expiration to avoid a lapse in coverage.

**MS ACTE** membership includes a number of professional benefits. One of these is the opportunity to participate in the optional Educator Professional Liability Insurance Program. Membership in MS ACTE is required for this important coverage. The cost is \$30 for the fiscal year which begins July 1. This policy is in force on the date of premium payment and expires on the following June 30. For uninterrupted coverage, renew each year on July 1. For insurance to be effective, you must keep membership in MS ACTE in force. The coverage includes up to \$1 million for liability, \$5,000 for attorney fees, and \$1,000 for bail bond premium.
